

AND WHEREAS, the institution submitted its reply on 27.11.2017, along with faculty list and stating as under:

*".....the NCTE in its 346 meeting consider the request for one unit and decided that the documents for one unit are in order except Staff list. We are here with submitting the staff list approved by Krishna University for one unit. If there are any other requirements also we will submit them immediately.*

*Krishna University is requesting us to ask one unit sanction order for 2017-18. Many institutions have got one unit order recently. Our institute is not got one unit order. Hence we request you is to give us at least conditional recognition order as given to the others. Otherwise we will lose this academic year.*

AND WHEREAS, the SRC in its 349<sup>th</sup> meeting held on 15<sup>th</sup> & 16<sup>th</sup> December 2017 considered the matter and decided as under;

1. Request for reduction from 2 units to 1 unit is accepted. Issue a formal order.
2. All other requirements are met.
3. Faculty list for B.Ed (1 unit) is in order.
4. Issue a new FR under the 2014 Regulations.

AND WHEREAS, the SRC in its 351<sup>st</sup> meeting held on 28<sup>th</sup> & 29<sup>th</sup> December 2017 considered the matter and decided as under;

1. Issue a formal order for reduction of intake strength from 2 units to 1 unit w.e.f.2017-18.
2. Issue a new FR under the 2014 Regulations for B.Ed (1 unit).
3. Thereafter, close the file.

NOW THEREFORE, the request of the above said institution for reduction of intake from 2 units to 1 unit in the B.Ed Course is permitted w.e.f. 2017-18.

ORDER

WHEREAS, Prathibha College of Education, Sy.No.123/1, 123/2, 123/3, NadimTiruvuru Village & Mandal, Krishna District, Andhra Pradesh made an application on 02.01.2006 for B.Ed course to SRC, NCTE Bangalore wherein was considered and recognition was granted to the institution for offering B.Ed course with an intake of 100 students from the session 2007-08 vide order F.No.SRO/NCTE/B.Ed/2006-2007/2188 dated 01.05.2007.

AND WHEREAS, the Government of Andhra Pradesh vide letter dated 06.03.2007 communicated that the state did not recommended the college. After following procedure, the recognition of the institution was withdrawal vide order dated, 22.10.2008.

AND WHEREAS, the institution continued to function on the strength of a 'stay order' granted by the Hon'ble High Court in the WPMP.No. 28724 of 2015 and W.P.No. 22271 of 2015

AND WHEREAS, the case was placed before SRC in its 344<sup>th</sup> meeting held on 17<sup>th</sup> & 18<sup>th</sup> August, 2017 as per RPRO cases which decided as under;

1. The College was functioning, on the strength of the 'stay' order of the Court.
2. The College has filed an affidavit to run a B.Ed.(1 unit) course and to abide by the 2014 Regulations.
3. In pursuance of this affidavit, let us process this case for recognition under the 2014 Regulations. It will be too late to issue an RPRO at this stage.
4. Documents have already been examined.
- 5.1 The Faculty list was found to have many deficiencies.
- 5.2 Issue SCN as already directed.ss
6. Put up in the next meeting.

AND WHEREAS, as per decision of SRC show cause notice was issued on 24.08.2017.

AND WHEREAS, the institution submitted its written representation along with approved faculty list on 16.10.2017.

AND WHEREAS, the SRC in its 346<sup>th</sup> meeting held on 24<sup>th</sup> & 25<sup>th</sup> October 2017 considered the matter and decided as under;

- 1.1 This is an old case of B.Ed.(1 unit) sanctioned in 2007.
- 1.2 It has continued to function on the strength of a 'stay' order from the Court after our withdrawal of recognition order in 2008.
- 1.3 Accordingly, this treated as a RPRO case.
- 2.1 As per the Court order, the institution was required to submit documents.
- 2.2 The documents were examined. Only the Faculty list was found to be defective.
- 3.1 They have submitted a revised Faculty list duly approved by the University.
- 3.2 Asst. Prof.(Tel)(Shri. Nageshwara Rao) has scored less 50%(i.e.'C' grade); hence not qualified.
- 3.3 Asst. Prof. in Fine Arts with P.G. degree is not there.
4. Issue SCN accordingly.

AND WHEREAS, Show cause notice was issued to the institution on 02.11.2017.


